

# LIMITED MAINTENANCE PLAN

## EASILY CARE FOR YOUR WELL-TRAVELLED CAR'S SERVICES AND WEAR-AND-TEAR ITEMS

The Limited Maintenance Plan runs for a set period of time (e.g. 3 years) or for a fixed number of kilometres (e.g. 45 000 km), whichever happens first. To ensure your plan stays intact, service your vehicle as per your car manufacturer's specifications.

### WHAT IS A LIMITED MAINTENANCE PLAN?

This plan provides for the replacement, maintenance and repairs for specific wear-and-tear parts, including wiper blades and brake pads. All maintenance repairs must be performed by an approved repair facility, for a specific period of time or specific distance travelled - whichever happens first.

This Limited Maintenance Plan is not a Warranty. A warranty provides for major unexpected mechanical breakdowns and electrical failures like engine or gearbox failure. Limited Maintenance Plan upgrades do not pay for services provided for by your OEM plan or current existing plans.

### WHAT IS WEAR-AND-TEAR?

*Wear-and-tear is a term used to describe the gradual physical deterioration of various parts of the vehicle. Wear-and-tear happens naturally and is inevitable as a result of normal use and ageing.*

- The financial institution that finances your vehicle may be able to incorporate the payments for your plan into your monthly vehicle instalment

## YOUR CAR QUALIFIES FOR A LIMITED MAINTENANCE PLAN IF IT

- Has travelled less than 120 000 km
- Is less than 5 years old (calculated from the date of first registration)
- No longer has an OEM Service Plan but has a full service history as per the required frequency and specifications - done by an approved repair facility.
